- FACILITY:** Competition Pool: Two 25-yard pools with ten-7.5-foot wide lanes each with non-turbulent lane markers. We will run one 10-lane 25-yard course for competition and the other will be used for warm-down. For selected events, FAST reserves the right to use the other 10-lane 25-yard course. A Daktronics 2000 Time System will be used. In the event of circumstances necessitating changes during the meet, information will be updated on the FAST website at www.fasttigers.com. Balcony spectator seating is available.
- PARKING:** Free parking will be available in the lots adjacent to the Fishers HS Aquatic Center.
- RULES:** Current USA Swimming and Indiana Swimming rules will govern the meet. Please pay special attention to rule 202.3.2 that states, "At a sanctioned competitive event, USA Swimming athlete members must be under the supervision of a USA Swimming member coach during warm-up, competition and warm-down. The Meet Director or Meet Referee shall assist the member in making arrangements for such supervision.
- ELIGIBILITY:** Age as of December 7, 2007 shall determine the age for each swimmer entered into the meet. All swimmers must be registered with USA Swimming. These registration numbers must accompany entry. Coaches must constantly display their USA Swimming coach credential to gain deck access. The meet referee or meet director reserves the right to ask for coach credential display and/or deny access if the coach does not comply.

MEET FORMAT: All Friday PM events are timed finals events. On Saturday and Sunday, all relays and 8-Under events will be swum as timed finals in prelims.

The Open 1650 Freestyle events (#41 & #42) will be swum as timed finals on Saturday. The top-10 seeded swimmers, after scratches, will automatically swim at night in finals. The remaining heats will be contested in prelims and swum fastest to slowest and alternating women & men depending on the number of heats of each.

The Open 1000 Freestyle events (#101 & #102) will be swum as timed finals on Sunday. All heats will be contested in prelims and swum fastest to slowest and alternating women & men depending on the number of heats of each.

The Fishers Area Swimming Tigers reserves the right to **limit the number of heats in all individual timed finals events to keep the time line manageable.** There will be refunds for all swimmers that get cut out of events.

All 1650 Freestyle and 1000 Freestyle swimmers are required to provide one timer and one lap counter.

Preliminaries will be conducted on Saturday and Sunday mornings for 13-14 & Open events, and Saturday and Sunday afternoons for 9-10 & 11-12 events. There will be consolation and championship finals heats (top-20) on Saturday and Sunday for the 9-10, 11-12, 13-14 & Open age groups. **All relays, Open 1000 Free and 8-Under events will swim as timed finals events in prelims.** The Open 1650 Freestyle will swim in prelims, with the top-10 fastest seeded swimmers swimming in finals.

If a swimmer misses their event, they will be declared a “no show” and will not be placed in any other heat to make-up the swim.

Fishers Area Swimming Tigers reserves the right to use “fly-over” starts for all events.

**POSITIVE
CHECK-IN:**

Positive check-in means, “I am here and I intend to swim this event.” **ALL EVENTS will require a positive check-in.**

Positive check-in sheets will be located at the security tables as you enter the pool area from the lobby on the deck level. All swimmers not declaring intent to swim via positive check-in will be scratched.

ENTRIES: Enter each swimmer with their full first name, last name, age and USA Swimming number on the entry. All times must be submitted in **SHORT COURSE YARDS TIMES AND COMPLETED TO THE HUNDRETH OF A SECOND. CONVERTED TIMES MUST USE THE HY-TEK TIME CONVERTER.**

Each swimmer in the 9-10, 11-12 13-14 and Open age group will be limited to three (3) individual events and one (1) relay per day. Each swimmer in the 8-Under age group will be limited to four (4) individual events and one (1) relay per day. If an entry is submitted with an individual entered in more events than this rule allows, the entry will be made by order of events starting with Event #1 until the rule is satisfied; there will be NO refunds.

FAST reserves the right to determine which entries to accept. Among the items FAST will consider when making these determinations are: teams will not be broken, number of officials and volunteers provided by the team, balance of age group and gender in entry, level of competition and geographic location.

The Fishers Area Swimming Tigers reserves the right to **limit the number of heats in all individual timed finals events to keep the time line manageable.** There will be refunds for all swimmers that get cut out of events.

EVENT SEEDING: There will be a positive check-in for all events.

ENTRY FEES: All entry fees must be paid by Friday, November 23, 2007. Please make check payable to: **FISHERS AREA SWIMMING TIGERS.** The individual events that are timed finals (8-Under, Friday Night & Distance Events) are \$4.00. The individual events that are prelims/finals are \$5.00 per event and all relays are \$6.00 per relay.

There is also a \$1.50 per swimmer, per meet, Indiana Swimming surcharge which must accompany entry.

DEADLINE: We expect this meet to fill up very quickly. **Entries will be accepted immediately. The final entry date for entries to be received is 5:00 PM ET on Friday, November 23, 2007 or when the meet is full, whichever is later. Teams not accepted will have their entries returned as soon as possible, but no later than by Saturday, November 24, 2007 via email or US Postal depending on the form of entry.**

Any accepted team entries may be updated until midnight on Monday, December 3, 2007. Updated times must be received via email. **NO PHONE UPDATES WILL BE ACCEPTED.**

The entry deadline will be extended if the meet is not full. Email confirmation of receipt will be returned. All email entries must be followed by a paper entry and check for entry fees. Please make your check payable to Fishers Area Swimming Tigers and enclose it in your entry. The meet will be run using Hy-Tek Meet Manager computer program (do not forget to "age up" swimmers to December 7, 2007).

A printed copy of your meet entries must follow your submission of your entries via email. **In all cases, the printed copy is the final word in any disputes involving entries.** Entries not submitted via email in Hytek format will be subject to a \$50.00 data processing fee.

A psych sheet will be posted on the Fishers Area Swimming Tigers website (www.fasttigers.com) after the close of entries.

FINAL RESULTS: One complimentary copy will be provided to every club with five or more swimmers. Extra copies may be ordered at the meet for \$8.00. Final results will also be posted on the FAST website at www.fasttigers.com.

AWARDS:

- Custom medals will be awarded for 1st through 3rd place finishers in all individual and relay events. Ribbons will be awarded for 4th through 20th place finishers in all individual events and 4th through 10th place finishers in all relay events.
- Team awards will be presented for 1st place, 2nd place and 3rd place visiting teams.
- High point award and runner-up in each age group (8-Under, 9-10, 11-12, 13-14 & Open)

OFFICIALS: The FAST will need the help of your **USA Swimming Officials**. If you have a member that is in charge of your officials, please provide his/her name & email address on the entry summary form where requested.

FACILITY NOTE: The Fishers High School Aquatic Center is one of the most beautiful high school facilities in the USA. It is important that all people attending this meet, whether it is swimmers, coaches, or spectators, treat this facility with the utmost care. The following rules will be strictly enforced:

1. Keep all trash picked up (swimmers and teams in particular).
2. Do not go, or let children go, in any unauthorized areas. This means any place other than the lobby or seating areas. Due to USA Swimming insurance requirements, **only** swimmers, coaches, officials and volunteers are allowed on deck. **There can be no exceptions!**

The Fishers Area Swimming Tigers will have security people roaming the deck and locker room areas. If any swimmer is caught abusing the building or facility, they will immediately be asked to leave the meet and will be barred from further competition.
